Feedback and questions response

- Why kommune funds not applied? Kommune consider applications for funds from the organizations with at least one year of existence (Need to provide previous year balance statement). NTA has applied for funds under special arrangements category and distribution of funds will be at Kommunes' discretion.
- By-Laws in Portal? By-laws will be uploaded to portal shortly.
- NTA executive board criteria? NTA executive board rotational period is specified in Paragraph §20 in By-laws.
 - § 20. Tjenestetid i styret.
 - a. Leder, Sekretær, Styremedlemmer tjenestegjør i to år. Tjenstetiden kan settes kortere eller lengre, men ikke til mer enn fire år. Ved suppleringsvalg kan kortere tjenestetid fastsettes.
 - b. Halvparten av styremedlemmer skal pensjonere hvert to (2) år, og skal erstattes av valget.
 - c. Tjenestetiden regnes fra valget når noe annet ikke er bestemt. Den opphører ved avslutningen av den ordinære generalforsamling i det året tjenestetiden utløper.
 - d. Selv om tjenestetiden er utløpt, skal styremedlemmet bli stående i vervet inntil nytt medlem
 - e. Et styremedlem har rett til å tre tilbake før tjenestetiden er ute dersom særlig grunn foreligger. Styret og den som har valgt styremedlemmet, skal gis rimelig forhåndsvarsel.
 - f. Suppleringsvalg. Opphører vervet for et styremedlem før tjenestetiden er ute, og det ikke finnes varamedlem, skal resten av styret sørge for valg av nytt styremedlem for resten av tjenestetiden. Hører valget under generalforsamlingen, kan det utstå til neste ordinære generalforsamling dersom styret fortsatt er vedtaksført.
- NTA Members list? NTA Members list (all) will be available to NTA portal shortly.
- > NTA News Letters? NTA news letters cannot be prioritized now as Executive board member efforts are focused on building NTA frameworks.
- Barneven event? This has been under consideration and will plan for such an initiative next year.

- Mythological story to kids has been arranged by our respectable Telugu fraternity member and very little response has been noted for two occasions. Therefore, any such events need to be met with decent participation from Telugu fraternity.
- > Telugu Language classes proposed by vidya (Abhyasan Coordinator) and arranged couple of classes. Again, limited participation.
- > Summer camps for Kids? NTA can't arrange such camps due to lake of participation or less participation, but NTA will actively provide summer camps related information from other organizations or schools.
- Recaching Immigrant parents? We have established very good communication lines with Embassy and NTA is constantly updating with Embassy news letters on monthly basis.
- > share the yearly financial statement of the NTA account with the members with details on how that funds are collected/used? Yes, we have planned to do it in NTA General body meeting.
- > Sharing balance sheet at the end of the event to all the registered people of that event?
 - Yes, started from Diwali event, here after we continue the same.
- Involve/encourage other people to support the event committee. Yes, will do.

Decisions proposed

- Change of Yearly membership to suit calendar year: Yearly Membership changing to Jan - Dec (earlier it is April to March)
- Encourage active participation of general members in the general body meeting to get detailed clarifications and annual financial summary.
